Scope 1	<p>Company vehicles.</p> <p><i>The company operate a fleet of vehicles in order to ensure our staff can cover the many geographies we cover in England and Wales. In order to affect positive improvements, we monitor business and private usage of all company vehicles, by engine type. In November 2021, we embarked on a process of selling off all our diesel vehicles with a view to moving entirely to all electric by 2030.</i></p> <p><i>The baseline totals for 2022 to 23 are:</i></p>

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets. Based upon our 2022 to 23 baseline measurements, we aim to take an aggressive approach to reduction in carbon outputs.

We project that carbon emissions will decrease over the next five years to 53.51 tCO2e by 2025. This is a reduction of 20%

We acknowledge that our current skills capacity to monitor accurate and meaningful emission usages is limited and therefore the company commits to achieving ISO 14001 accreditation by the end of the financial year April 24 to March 25.

Achieving this accreditation will mean that we are able to review our targets and update our scope and reduction initiatives in more meaningful and impactful ways.

We will also increase the scope to include our supplier base and ensure that our purchasing decisions are influenced by the Carbon Reduction Plan.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented during or before the 2023 baseline.

The carbon emission reduction achieved by these schemes equate to **0.61 tCO₂e**.

Solar Panels installed at Head Office

LED Lighting installed at Head Office

Removal of all diesel vehicles now achieved, meaning that 2023 to 24 business mileage figures will reduce accordingly.

In the future we hope to implement further measures such as:

ISO 14001 accreditation by March 25
